



- 9.1 If a bidder is MSME/Udhyog Aadhar/SSI registered manufacturer of Madhya Pradesh then they will be exempted from submitting EMD and Bid document fee. However tender processing fee is not exempted. If MSME/Udhyog Aadhar/SSI registered bidder wishes to avail above facility then they should follow necessary Exemption of Tender Document Fee & EMD is only for MSME/SSI Manufacturers of Madhya Pradesh. To claim the exemption, relevant valid documents, in support of MSME/SSI, are required to be uploaded by the bidder(s). Without relevant document bid may be rejected. MSME/SSI Manufacturer(s) from other States are not exempted from EMD and Tender Document Fee. If other than MSME/SSI manufacturer of MP do not submit EMD and/or do not pay bid document fee, then such bid shall be rejected.
